The article presents the structure of subgenus *Trogophloeus* for Tropical Africa, gives the data on its distribution. Lectotypes are designated: *Trogophloeus apicicornis* Fauvel, 1900; *Trogophloeus sanguinicollis* Bernhauer, 1932; *Trogophloeus gerardianus* Bernhauer, 1933; *Trogophloeus punctiger* Bernhauer, 1934; *Trogophloeus collarti* Cameron, 1935; *Trogophloeus globicollis* Eppelsheim, 1885; *Trogophloeus lisfranci* Bernhauer, 1938; *Trogophloeus padangensis* Cameron, 1928; *Trogophloeus parcepunctatus* Bernhauer, 1934; *Trogophloeus nigripes* Cameron, 1953. The article presents the results of studying of *Staphylinidae* fauna of the riverine zone of the Sozh river within Smolensk region according to the materials of the author's research during the period of 2009–2011. Two species (*Mycetoporus despectus* Strand, 1969 and *Stenus providus* Erichson, 1839) of rove beetles were registered for the first time for Smolensk region. A list of species of rove beetles is given for each one of the 6 marked types of the Sozh banks, a comparative analysis of their population is provided.

The conclusion is made about the coincidence of large transgressions with periods of cold weather, and the spacing of boulders at considerable distances is due to the erosion and carrying role of floating ice.*
