SCHUBERT'S «THE TROUT» IN RUSSIAN POETRY

Franz Schubert is one of the well-known western composers in Russian poetry due to the fact that poets have been attracted by his laconic plots, relation to legends, melodramaticism and deep symbolism going beyond historical symbolism. In Russian poetry the small play «The Trout» acquired a meaning different from the composer's intensions. It began to be understood not as a moral tale of caution and temptation and not as a hymn to youth and young feelings, but as a call for freedom of improvisation.

The article, based on material from Russian poetry of the XXth century, immigrant and modern poetry, examines the reasons for the bias in the understanding of the play. The article thoroughly analyzes rhetoric of the text «The Trout» and features of its perception in modern and contemporary lyrics. The author indicates factors of meaning bias such as a biographical subtext of «The Trout» creation, Schubert's general image mainly as a romantic composer, an implicit competition between poets lived at the same time for the correct understanding of musical rhetoric. The research methods include reconstruction of the composer's reputation in Russian culture, a comparative historical analysis and hermeneutics of a poetic text, and specification of musical allusions.

Thanks to the individualization and analysis of the stages found in the transformation of the «The Trout» perception in Russian poetry, it is proved that the musical work perception is associated with a special understanding of media nature like the play brevity, its distribution, the first publication in the newspaper, its use in parodies and mass culture has made the author understand «The Trout» as a democratic work with its own media principles. In addition, the richness of Schubert's legendary and ballad plots and the need to artificially build Schubert's world within a short lyrical work have turned «The Trout» into an exemplary key of the plot. The ballad starts to be interpreted

through poetic form as the opposite to the work with morality; musical intonation is understood as a gesture of gaining freedom contrary to the literal content of the ballad.

**A.S. PUSHKIN'S LITERARY WORLD
IN THE CREATIVE PERCEPTION BY A.T. TVARDOSKY
AND A.A. KULESHOV**

The article is devoted to the creative development of A.S. Pushkin's poetic tradition in the works by A.T. Tvardovsky and A.A. Kuleshov. The material of the research is based on the lyrics, criticism and journalism of the writers worked in different years.

According to the study hypothesis, the models of A.S. Pushkin's tradition realization in A. Tvardovsky's and A. Kuleshov's literary worlds are characterized by a wide variety and adaptation at several levels such as a theme of the work, a poetic motif, a literary image, a genre and principles of literary thinking.

In conclusion of the study, it is argued that the relationship between the works by A.A. Kuleshov and A.T. Tvardovsky is manifested (from the perspective of different themes, motives, genres, images) through A.S. Pushkin's perceived assessment of reality, i.e. «A.S. Pushkin's individual world-attitude» (according to V.D. Skvoznikov). «Pushkin's individual world-attitude» is understood as skills to perceive and reflect not only the global historic events, but also everyday phenomena of a trivial order, an ability not only to identify themselves in these various events, but also to assess the course of these events in their own poetic world.

ONCE AGAIN ABOUT SO-CALLED BRODSKY'S «SYLLABICS» AND ITS OBJECTIVE CONTEXT – RUSSIAN SYLLABICS OF THE LATE XX CENTURY

The article considers existing opinion in modern science devoted to Brodsky's about the rhyme in his two poems written in the middle of the 1960s. These poems («The Poetry», «Imitation of Cantemir's Satires») appeal to the name and word of Cantemir. On the basis of this fact and due to the use of unconventional forms of syllabotonics (dactyl with two caesuras) and tonics (accentual rhyme with a constant clausula), the author often makes a conclusion about syllabic nature of these poems. The author of the article explains the reasons for the error and suggests ways of solution. In addition, the context of this error is shown in regular appeals of Russian poets of the late XX century to the memory of the syllabic rhyme and its experiments appeared a bit later. The article presents examples of modern Russian syllabics stylized and completely original.

DYNAMICS OF THE ESTATE SUPERTEXT FUNCTIONING IN RUSSIAN LITERATURE:

SEMANTICS, SYNTACTICS, PRAGMATICS

The purpose of the article is to study the diachronic aspects of the supertext functioning as a semiosphere on the example of the estate supertext in Russian literature. Each fragment of the estate semiosphere, due to its iconic nature, is organized in accordance with the semiosis levels: semantics (a myth, a system of oppositions, motives and toposes), syntactics (linear connections between semantics components) and pragmatics (a communication system in the text, a subjective structure).

In the iconic organization of the supertext, semantics refers to the paradigm level and composes an invariant system of values, which ensures the integrity of the supertext and the meaning continuity. The semantic components are concretized at the syntactic level in different contexts (the context of syntagma, the context of the author's work, the historical context) and the plots (a consistent connection of motives and images). Out-of-text and in-text communications are reflected at the level of pragmatics (an author's dialogue with tradition, various forms of quotations, involvement in aesthetic polemics of the era, inter-semiotic translation into different literary languages).

Thus, syntactics and pragmatics refer to peripheral fragments that belong to the semiotic field of the estate text and they are primarily subject to changes in the diachronic development of the supertext. This semiotic model can become a universal one for studying the dynamic aspects of large supertext (overtext) formations.

SIMILATIVE CONSTRUCTIONS IN HITTITE «SONG OF ULLIKUMMI»

The article is aimed at the analysis of simulative constructions with the semantics «X like Y» in Hittite epos the «Song of Ullikummi». Contextual analysis allows the author to detect this type of collocations without any markers like asyndetic constructions (with juxtaposition, a chain of accusatives).

The author of the article has studied the word order in these constructions. It has been shown that the similarity phrase regularly takes place in the immediate preverbal position after the object and the adverbial modifier of place in a linear structure. It is interesting to find contexts with a standard of comparison in the initial position of the clause, which points out to the upper (and marked) focus position. This type of placement mostly correlates with right dislocations, frequent in the Hittite poetic language.

As for the linear word order, constructions with conjunction «like X», as a rule, appear as a sequence «a comparee – a standard of comparison – a marker of the standard». The rare sequences «a standard – a comparee – a marker» show markedness connected to the needs for information structure, which demands further research. In asyndetic constructions the standard sequence appears as «a comparee – a standard». In the paper it has been shown that simulative constructions in the «Song of Ullikummi» actually lost the proper similarity semantics and serve as markers of certain qualities of poetic images.

SUPERTEXTS IN THE RUSSIAN DRAMA AT THE TURN OF THE XXTH–XXIST CENTURIES

The article is devoted to the study of supertexts phenomenon in contemporary Russian drama. Famous philologists' points of view are compared, definitions of super-text are suggested, and its features are highlighted. The author of the article distinguishes macro components of the supertexts in fiction, among which there are motifs, images, plots, types and forms of intertextuality and biographical myth. The overt text in literature is understood as a supra-textual formation, a set of meanings that arise in the process of interaction between texts distanced from each other, as well as different receptions of the writer's personality and his/her literary heritage.

The article analyzes problems of the supertexts typology in modern Russian drama and the selection criteria. Based on a set of features that determine the precedent personality and the «strong» text among them, the Shakespeare's, Chekhov's and Gogol's supertexts are distinguished in Russian

drama at the turn of the XXth–XXIst centuries. The perspective «personal» texts are also marked: Pushkin's, Lermontov's, Goncharov's and Dostoevsky's ones.

The remake is considered as a genre under the influence of the meanings of the «personal» text. The remake in drama is proposed to be considered as a work that is most representatively involved in the formation of «personal» supertexts. The writer's biography and his/her works cease to be a fact of literary history and leave the literary field, they turn into a myth and overgrow with meanings due to the authors' reception, critics and literary critics of subsequent generations. «Personal» supertexts are expanded due to the parodic interpretation of classical prototexts, the destruction of the biographical myth and its reception.

CONTEXTUALIZED PRAGMATIC CHARACTERISTICS OF INVITATION SPEECH ACTS IN THE RUSSIAN LANGUAGE CULTURE

Due to methodological and theoretical variety in approaches as well as in contingencies while investigating invitation speech acts, the findings concerning their pragmatic characteristics have turned out to be different. This paper is an attempt to determine sociocultural features, pragmatic implications and representation in the dialogue corpus of various types of invitations in Russian culture using contextual interpretation and pragmalinguistic analysis.

The findings demonstrate a frequent usage of addressee-oriented declaratives, followed by imperatives, questions and addresser-oriented declaratives with the meaning of a command. All these invitations are in fact direct obligatory impositives. However, within the context of Russian culture they reveal the use of positive politeness strategies.

The speech act of invitation cannot function on its own – it is semantically and pragmatically connected to pre-invitation sequence, which makes it a complex speech act.

The benefactive status of the addresser is enhanced due to the obligatory nature of the invitation which also ensures the speaker's confidence about the successful outcome of the interaction, therefore there is no need for the inviter to resort to indirectness and negative politeness strategies.

There are cases of self-invitations where an invitee takes the initiative, whereas an inviter has to perform a speech act with a weakened illocutionary force.

VARIATION OF THE DNIIEPER BASIN HYDRONYMY ON THE TERRITORY OF THE SMOLENSK REGION

The article is devoted to the analysis of the Dnieper water bodies nominations on the territory of the Smolensk region. The research is aimed at consideration of the most important onomastic problem at present – variation in the sphere of the proper names, particularly in the hydronymy.

Amidst the regional onomastic development, the research in the sphere of toponymy and hydronymy is being actively carried out, toponymic dictionaries are being published. In these dictionaries the variants of the geographical objects are often only marked down. However, more focused attention to the revealing and describing the reasons and methods of their variation allows the researchers to carry out more detailed diachronic analysis of the onyms existence in the different historical periods and define the invariants formation.

The most interesting field of research is the toponymy and hydronymy study of the Smolensk region – western border region of Russia. The material of the research is based on the military-topographical map of Smolensk Governorate, large scale maps and an atlas of the Smolensk region, as well as written information sources. The author has analyzed the examples of the orthographical, phonetical, morphological and lexical variants of hydronyms and has tried to reveal the linguistic and extralinguistic reasons of the water bodies nominations variation in this region.

It is proved that the hydronyms variants origin is typical for small water currents; it is linked with their shallowing and the loss of their significance in the economic life of the population. The predominance of the phonetical variants is explained by the influence of the general-linguistic process, a local dialect, a living colloquial language. The variation on the word formation level is widely represented by diminutive forms as a result of the changes in the water currents physico-geographical parameters.

Lexical variation of the hydronyms in the region depends on the nominations de-etymologisation. Moreover, in the analyzed region the author has found out a lot of variants of hydronyms with changes at different language levels. Linguistic and extralinguistic reasons of variation in hydronymy are closely linked. This fact can make it more difficult to determine the method of the new variant creation. The analyzed factual material will be practically used in the «Hydronym's Dictionary of the Smolensk Region», which will be published soon.

PECULIARITIES OF THE RUSSIAN LANGUAGE PRESERVATION BY THE RUSSIAN SETTLERS' DESCENDANTS IN CHINESE REGION OF THREE RIVERS IN THE XX CENTURY AND AT THE BEGINNING OF THE XXI CENTURY

The territory of Trekhrechiye is the Region of Three Rivers (Sanhe, the District of Hulunbuir, Inner Mongolia, the People's Republic of China). This territory is subject to scientific study by historians and philologists. The research objects of this article are language aspects of modern Trekhrechiye.

The aim of the study is to describe language competence of the Russian settlers' descendants, who live now in the Region of Three Rivers, that place became mass residential centre of the Russian people in the XX century. Moreover, it is important to show dynamics of the people's competences of the Russian language throughout the entire period of the Russian presence there.

The description of the language competence of the Russian settlers' descendants of different generations is based on the results of scientific expedition to the Region of Three Rivers. The expedition took place in 2017–

2018 and was undertaken by the author. It allowed the author to monitor the extent of the Russian language preservation in different generations.

INTENTIONAL LEXICAL MEANINGS AS AN OBJECT OF RESEARCH

The article studies the linguistic research corpus, devoted to the expression of the meaning «volitional action» by means of the semantic structure of the lexical units representing the notion «intention». The main aim of the paper is to systematize the comprehensive data on the topic under study, coined since the early XXth century to the present day both in Russian linguistics and abroad. Analytical description of the theoretical sources is based on the five following criteria: the criterion of motivation for singling out a research object from the reality continuum, the criterion of terminology, the criterion of methodology, the criterion of categorial features of the object, the criterion of semantic individuality discriminating parts of the object.

The research results in the conclusion that the approaches to lexical volition are isomorphic in terms of the most essential criteria – those of motivation for singling out a research object, methodology applied to it and its categorial features. Thus, in the papers considered the rationale for studying intentional lexical meanings is their anthropocentricity, the universal method of surveying them is componential analysis; the studied categorial features include intentionality, prospectivity, purposefulness, and agentivity.

The controversies in the authors' perspectives are also brought to light and treated as an object of new research, requiring the respective theoretical corpus, systematized in the present paper.

The amount of linguistic research, dedicated to the study of lexical units based on the names of animal world's representatives, grows every year. One of

the reasons for this particular interest lies in the lack of sufficient theoretical base which could enable scientists to systematize the necessary cultural and sociolinguistic data.

Researchers consider animals' names in searching for the cultural code of a definite ethnic group, as well as pointing out specifics of the figurative component of thematic groups included in zoonyms. This approach allows them to examine those additional meanings that a certain lexical unit acquires within the stated national culture. The consideration of the corresponding units in the context of African-American writers' works is of great interest within the originality of the plots themselves, as well as the folkloristic and mythological background found in the majority of the constructions with the zoonym element. The novel «Sula» by an outstanding writer Tony Morrison is one of these works. The writer's texts are based on unique cultural and historical experience of African-Americans, specifics of their self-knowledge with an inherent belief in magic and myth.

This article examines the termbase used for the analysis of zoonym-containing lexical units. The most frequent nominations used for the evaluation of human characteristics and actions are demonstrated and described on the basis of the selected examples. Three categories of nomination (age, behavior, appearance) are considered in greater detail. The author of the article makes a conclusion about the frequency of the constructions with negative, neutral and positive connotations within the stated groups, as well as their usage for the description of a person's preferred and criticized qualities.

A CRITICAL ASSESSMENT OF THE NOVEL «ASSEMBLY HALL» BY HERMANN KANT IN THE REUNIFIED GERMANY (AFTER 1991)

H. Kant's novel received a high literary and aesthetic appreciation in criticism and wide recognition by readers. Criticism (before and after the unification of Germany) concerns mainly one aspect viz. authenticity of the events depicted in the novel and the characters' images. Opponents argue that Kant's ideological views, his consistent socialist and party position have prompt him to embellish reality, create simulacra, and the idyllic world of socialist Biedermeyer. The article shows that these assessments ignore the nature of his talent, especially his creative personality peculiarities such as journalistic orientation of the motivated «political» person and writer.

REPRESENTATION OF THE FRAME «MOVING IN SPACE» THROUGH THE VERBS OF MOVEMENT IN THE GERMAN LANGUAGE

This article discusses MOVING IN SPACE frame in German, defines its concepts and slots that find their language expression through the eight most common verbs of the movement such as gehen, laufen, kommen, wandern, treten, fahren, fliegen, schwimmen.

The basis for constructing the frame is a technique of identifying integral and differential semes. The identified integral semes allowed the authors to

define four concepts: the medium of movement; nature of movement; means of transportation; intensity of movement.

Using corpus research based on the COSMAS electronic linguistic corpus, the study reveals the ability of verbs to express various slots of established concepts. The carried out semantic analysis has made it possible to identify the verbs of movement gradation according to the representation of slots in the frame structure MOVING IN SPACE.

The verb with the most extensive semantics is the verb «kommen», since it is able to express the largest number of slots during operation.

The dominant concept in the frame structure MOVING IN SPACE is the «medium of movement», since this concept determines the specification of the remaining selected slots.

The findings of the analysis are reflected in the cognitive map of the MOVING IN SPACE frame including the set of individual concepts (integral attributes) and slots that implement them (differential semes).

TRANSFORMATIONS IN THE JUDICIAL SYSTEM OF THE SMOLENSK REGION (1917–1922)

The article analyzes the results of the state policy implementation within the formation and development of the Soviet judicial system on the example of Smolensk Governoral Court.

The authors set the goal, based on the analysis of sources not introduced into a wide scientific circulation, primarily stored at the State Archive of the Smolensk Region, to restore the history of the creation and operation of justice institutions in the Smolensk region in the 1918s–1923s.

The source base of the study was composed of documents stored at Smolensk State Regional Archive, materials on the history of the judiciary, statistical materials of the period under the study, documents on the history of the party-state bodies of the Smolensk region.

The article studies current office documentation of both the higher and regional state bodies (Workers' and Peasants' Government, People's Commissariat of Justice, Smolensk Governoral Executive Committee) and local authorities (Smolensk Council of Working People's Deputies, Executive Committee of Smolensk Governoral Council of Workers, Peasants' and Red Army Deputies), as well as Smolensk Governoral Court.

The authors analyze the Soviet experience in the formation and development of judicial bodies under specific historical conditions; they consider transformations in the judicial system of the Smolensk Governorate in the 1917s–1922s, as well as the formation of Smolensk Governoral Court. The article studies legal foundations of the Soviet judicial system formation,

characterizes processes of creating a judicial apparatus in the first years of Soviet power and analyzes activities of Smolensk Governoral Court during its formation.

The authors reveal the essence, degree of efficiency, concrete results, political and socio-economic consequences, positive and negative lessons from the Soviet judicial system existed in Russia.

The authors assume that the development of new legislation system in the 1920s was caused by the need to reform legal sources as the main means of socialism building.

The authors conclude that the transformation of the Soviet judicial system completed the transition from the principle of «revolutionary expediency» to the principle of «revolutionary legality».

CONCESSIONS OF THE 1920S – THE FIRST ATTEMPT

TO ESTABLISH ECONOMIC RELATIONS WITH THE WEST

The article analyzes the use of concessions to attract foreign capital and technology in an almost complete economic blockade because of the revolution and civil war, as well as the fact that the revolution in other foreign countries has not occurred.

The article indicates particular regulations in the procedure for the infusion of foreign concessions into Soviet Russia. In addition, the paper points out how this process gradually developed, as well as what problems arose for western investors in the course of investing their capital in the country.

The author shows particular industries that mostly used foreign capital, names donor countries, and provides statistical data on the number of applications for the opening of concessional filed by foreign investors.

The paper provides examples of specific concessions. The author draws attention to the careful selection of concessionaires, states the principles of concessions' operation in terms of planned and command economy. The original literature of the 1920s is used in the article. The aticle defines the concessions' place and role in the Russian economy.

The author points out that the questions arising between the Soviet power and foreign investors concern price policy and employed workers' compensation that, however, was not typical of all concessions. Moreover, the article provides statistical data concerning the number of contracts concluded in the main sectors of the economy and the benefit it brought to the economy, as well as the number of citizens of Soviet Russia involved in the economic activities of foreign concessions.

The author makes a conclusion that the state policy of concessions was a forced measure aimed at improving the state economic development by attracting foreign capital and technology.

THE STATE OF THE SOVIET FILM INDUSTRY IN THE 1930S

Soviet cinema of the 1930s has long been of particular interest for historians from Russia and abroad. For a long time in historiography, the Soviet art of the 1930s has been associated with the Soviet ideology and propaganda of the stated period. This topic was considered by the outstanding historians such as David Brandenberg, Boris Ilzarov, Yevgeny Gromov, Alexander Dubrovsky, Katerina Clark, etc.

At the same time, in the studies on this topic, as a rule, focuses is made on the formation of Russian national ideology in the Soviet Union in the 1930s. In the center of historical research there are literature and cinema cultivating Russian national historical heroes. Besides, cinema comes to prominence in the 1930s. However, in historiography the state of the Soviet film industry in the proposed period is very poorly covered.

This paper discusses the state of the Soviet film industry in the 1930s. Based on archival materials of the Main Department of Film Affairs, on the paperwork related to the development of the film industry, as well as memoirs of contemporaries, the author assesses the state of the Soviet film industry at the turn of the 1920s–1930s, as well as traces the development of the film industry in the 1930s. The author highlights the most significant problems of the Soviet cinema of the 1930s, as well as the main projects for solving these problems. Thus, this study makes it possible to assess the state and production capacity of the Soviet film industry in the 1930s.

RESTORATION OF THE DONBASS EDUCATIONAL INSTITUTIONS NETWORK IN THE POST-WAR PERIOD (1943–1954)

The article is devoted to the peculiarities pointed out in the process of restoration of universities network, vocational and comprehensive schools in the post-war period, namely, the legislative activity in the educational field, the revival of the educational and technical base, recruitment of the teaching staff. The importance of a comprehensive research of the period under the study is vital due to the social and political events and their impact on the revival and development of the Donbass region, as well as the USSR as a whole.

Teachers and pupils of schools, professors and students of secondary and higher educational institutions began to restore the educational institutions immediately after the Donbass liberation from the Nazis in 1943. In the first post-war year, due to common efforts, it was possible to resume the educational process almost in all educational institutions. In connection with the law «On

Compulsory Education for Children from the Age of Seven», the educational system was given a task to cover all school-age children and adolescents who had not attended school for several years because of hostilities and occupation. Consequently, every month the number of students increased, which led to an acute shortage of teaching staff. This problem was insoluble, since many teachers continued to serve in the Red Army or died while doing military duties to the Motherland. In restoration of the regional industry there was need for highly qualified personnel, who were able to fill the reviving Donbass enterprises thanks to the well-established work of secondary and higher vocational educational institutions.

In disclosing the topic, a special place is given to archival sources, the analysis of which made it possible to comprehensively study the problematic issues of that period and determine future prospects of the research.

THE REPUBLIC OF THE UNITED PROVINCES POLICY AT THE PEACE OF WESTPHALIA CONGRESS AND THE PEACE OF MÜNSTER CONCLUSION

The Northern Netherlands fought for liberation from Spanish rule for 80 years. The country needed peace and confirmation of sovereignty. Spain, weakened by the war, was also interested in a peace treaty conclusion. Dutch-Spanish negotiations at the Peace of Westphalia Congress had not been held until January, 1646. The parties relatively quickly agreed on the basic terms of the agreement. They managed to resolve the issues of colonial conquest, trade, and the closure of the Scheldt.

The contradictions, remained unresolved, concerned the position of the Catholic religion on the Lands of the Generality. However, there was no unity regarding the conclusion of peace in the republic itself. The province of Zeeland opposed the conclusion of the treaty. Despite this fact, in January 1647 a preliminary peace agreement was signed. It should come into force in case of signing the same Franco-Spanish agreement. In accordance with the Franco-Dutch Union Treaty, its parties undertook not to conclude a separate peace. However, France and Spain could not come to an agreement. As a result of the internal political struggle in the republic, the victory was won by the supporters of the separate peace conclusion.

On January 30, 1648 the Peace of Münster was concluded between Spain and the Republic of the United Provinces. On May 15, 1648 the parties exchanged instruments of ratification. At the end of May, 1648 the province of Zeeland agreed to the peace concluded.

CELTIC FRINGES AND CENTRAL POWER IN GREAT BRITAIN: HISTORY AND MODERNITY

The article deals with history of interrelations between political centre and Celtic fringes of Great Britain in modern and contemporary times. As soon as nationalist movements in Celtic fringes became more active from the mid-1960s, the need appeared to analyze the history of interrelations between central power and Celtic regions in order to understand causes of Celtic people's striving for obtaining more rights and even state independence.

The article ascertains that attitude of central power to Celtic fringes was complicated by ethno-cultural differences between Englishmen and Celtic people, which resulted in discrimination of Scotland, Wales and Ireland by London's policy towards Celtic regions. Since British industrialization evolved the central power in Great Britain, it created conditions for balanced comprehensive development of industrial economy only in English counties, whereas Celtic regions were permitted to develop only branches of economic activity which were non-competitive to English business. The level of people's income in Celtic fringes was always lower than in English parts of Great Britain. There was an established practice that English business dominated in Celtic regions and determined the economic development of Celtic regions. The English as distinct from Celts had prior opportunities to be engaged on more prestigious and highly paid positions. Celtic population's devotion to preservation of their culture and ethno-cultural identity found expression in religious sphere so that Nonconformity and Presbyterianism accordingly dominated among Welshmen and Scotsmen. Political movements in Celtic

fringes put forward ethno-cultural demands rather than social class ones in their activities.

During the first half of the XX century the opposition between Celtic fringes and central power in Great Britain showed that in parliamentary elections Celtic population gave their votes mainly for the members of Labour Party. From the mid-1960s nationalist movements in Celtic fringes became more active. They began to make slogans of political independence. The author of the article comes to conclusion that interrelations of central power in Great Britain towards Celtic fringes can be adequately described by notions of I. Wallerstein's world-system analysis and M. Hechter's model of internal colonialism.
